### **Type of Information Collected and How We Collect It:**

We only collect personally identifiable information (name, email) that you provide in contacting us, or provide us in any other way. In addition, we may collect the Internet protocol (IP) address used to connect your computer to the Internet. We may also gather additional (non-personal) information automatically by a web server software, for example, statistics on which pages are viewed at what times by visitors of the website. This software does not identify and track individual users, and it does not connect the personal information that may be provided by you to any web-tracking statistics or report.

### **Why do We Collect Personal Information:**

We collect such Non-personal and Personal Information for the following purposes:

1. To respond to User inquiries about our firm or services;
2. To be able to contact our Visitors and Users with updates about our firm or provide new Insights pieces as subscribed;
3. To create aggregated statistical data and other aggregated and/or inferred Non-personal Information, which we or our business partners may use to provide and improve our respective services;
4. To comply with any applicable laws and regulations.

### **How do We Store, Use, Share and Disclose Personal Information:**

Our company is hosted on the Wix.com platform. Wix.com provides us with the online platform that allows us to provide information about our firm and services to you and respond to your inquiries. Your data may be stored through Wix.com's data storage, databases and the general Wix.com applications. They store your data on secure servers behind a firewall and do not share your personal information with other third parties.

We collaborate with other companies and individuals to perform services for us and on our behalf and we collaborate with other companies and individuals with respect to products or services ("Providers"). Examples of Providers include data analysis firms, CRM vendors, email and SMS vendors, and web-hosting and development companies. Some Providers collect information for us or on our behalf on our Website. These Providers can be provided with access to personal information needed to perform their functions.
